



Emerging Leaders Internship:

Understanding the Finances

Exodus is committed to making Internships accessible for all.

The Emerging Leaders Internship is heavily subsidised by Exodus and every effort has been made to keep costs low. We aim to help successful applicants manage the financial burden by offering support, flexibility and encouragement. Below is an outline of the costs associated with the internship and some suggestions as to how to meet them. Cost 1: Programme Enrolment £250

Successful applicants will be asked to contribute £250 towards their internship. Although the programme is heavily subsidised by Exodus, this fee helps to cover some basic costs.

How to Pay

- Pay in one instalment by 1st Sept 2024
- Pay £25 monthly for 10 months, beginning in Sept 2024
- Raise support through a one-off gift.
- Raise support through a regular gift over a maximum of 10 months beginning in Sept 2024.

Cost 2: Interns Leadership Adventure £550

Each Spring, Interns are invited on a 'Leadership Adventure' in Romania. This is a unique opportunity to experience a new culture, learn about leadership and serve others. Interns are asked to contribute £550 towards the running costs of this trip.

How to Pay

- Pay in one instalment in November
- Pay in 3 instalments between November and March.
- Ask your Church to sponsor you.



Emerging Leaders Internship:

Frequently Asked Finance Questions

What is the expenses policy?

Exodus offers full time interns expenses of up to £150 per month for commuting and meals consumed during work. For part-time interns, these expenses will be adjusted accordingly.

If I am asked to join or lead an Exodus team, will I have to pay?

Exodus provides every intern with a £500 bursary towards their team. This covers the personal contribution towards any Irish team and most European teams. In the event where an intern wishes to travel further (e.g. South Africa) this £500 will be taken off the personal contribution and the intern will be asked to pay the remaining balance. Interns are expected to support team fundraising efforts as normal.

What if I cannot afford the costs outlined above?

Exodus heavily subsidises the internship programme to keep costs as low as possible. This means that the cost of the internship is fixed. At the same time, however, we wish to provide support and flexibility where possible. Do Exodus provide transport or accomodation?

Exodus do not provide transport or accommodation for interns. While owning a car is not essential for interns, careful consideration should be given to daily transport to and from work, especially for programmes and events outside of normal 9-5 working hours.

Can I get a part-time job during my internship?

Of course! Each internship has different demands on time and flexibility is available for those who have other work demands. If you are invited to an interview, please be prepared to discuss your availability.
